SCHEDULE OF AMENDMENTS TO THE THE DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS OF THE LINKS

1. ARTICLE VI, GENERAL COVENANTS AND RESTRICTIONS, Section 1. of the Declaration is amended to add an entirely new Subparagraph 1.(a) to read as follows:

Section 1(a) Leasing. Leases shall be prohibited for the first twenty-four (24) months after acquiring ownership of a Lot. The Board shall be notified in writing, on such forms as it may require, of the proposed lease and may require submission of a true and fully executed copy of same.

2. ARTICLE VI, GENERAL COVENANTS AND RESTRICTIONS, Section 1. of the Declaration is amended to add an entirely new Subparagraph 1.(b) to read as follows:

Section 1(b) Lease Terms. Leases for a term of less than six (6) months are prohibited and a Lot may not be leased more than three (3) times in a calendar year.
